## Medical Release

In the event that a medical emergency arises while a pet is at our facility it is imperative that we are immediately able to get them medical treatment. Our goal is to get your pet medical attention as quickly as possible and any distractions may interfere with that process. For that reason, it is a requirement to have our pet parents sign this form.

If my pets that are boarding at The Retreat at Creekside become ill, I request Creekside Animal Clinic, Inc. provide all medical/surgical treatment deemed necessary. I acknowledge that in the event of my pet's illness, the staff of The Retreat at Creekside might not be able to contact me immediately. Nonetheless, the staff and Creekside Animal Clinic and The Retreat at Creekside are permitted to administer proper treatment to stabilize my pet until either I or one of my authorized agents can be reached. I agree to pay all related medical fees associated with the treatment of my pet until I can discuss further care with the attending veterinarian.

The Retreat at Creekside will call the contact number listed on your account to notify you before your pet is transported to Creekside Animal Clinic as The Retreat staff starts treatment as needed to maintain your pet's well-being. You will be charged the associated fees for any services, diagnostics, or treatments necessary to stabilize your pet.

\*In the event that the medical emergency occurs while Creekside Animal Clinic is closed, or if the size and scope of the medical emergency is deemed to be more than the clinic can reasonably handle, replace all instances of Creekside Animal Clinic with Metropolitan Veterinary Hospital.

Diarrhea is common among dogs while boarding, due to stress. We will administer a pro-biotic (Forti/Flora) @ \$2/day when we see a change in stool. Should the problem persist for more than 24 hours, we will be in contact for further treatment options.

My pet currently does not have history of seizures, is not on any controlled medications, or is experiencing any life threatening conditions at this time, to the best of my knowledge. If yes, please explain:

In addition to the above policy on the health of my pet and any treatment that may be needed in the unlikely case of a medical necessity arising with my pet, I also agree to abide by The Retreat at Creekside's Medical Release policies:

- The Retreat at Creekside will not be liable for problems caused by your pet eating bedding or other items in his/her kennel or any other self-inflicted injuries from your pet's behavior while in the kennel.
- I will allow Creekside Animal Clinic Veterinarians to prescribe Metronidazole (an anti-diarrhea medication) if need be without a previous exam.
- I understand that while my pet(s) is fully vaccinated, that vaccines are not guaranteed and there is a small risk that my pet(s) may contact a contagious disease or illness. I agree that should this occur, I am responsible for my own pet's care, medical attention, and costs.
- I release The Retreat at Creekside, its staff, owners, and any representatives from all liability which I or my pet(s) may suffer including but not limited to injury, sickness, damage, or death resulting from participation in boarding.
- I represent that my pet is social and has not harmed or shown threatening behaviors towards any person, dog, or other animal. I understand The Retreat at Creekside reserves the right to move my dog to a Houdini Run if deemed necessary. I also understand that the rest of my pets stay will be billed at the appropriate amount for the new accommodations.
- I agree to allow 14 days waiting period after my pet as had their vaccinations to allow the vaccines to reach full protection potential and to ensure my pet has not has any negative reaction to the vaccines. Should I allow my pet to stay at The Retreat at Creekside less than 14 days after vaccination I understand that my pet could be at risk of contracting a contagious virus/disease.
- I agree to disclose any previous or current medical issues or concerns of my pet so that The Retreat at Creekside's staff can decide of suitability for boarding.
- I release The Retreat at Creekside from any liability should my pet injure another pet or person and accept medical and legal responsibility for my pet's actions.
- I release The Retreat at Creekside from any liability should death of my pet occur for any reason while in daycare or off-site overnight boarding.
